What is the overall <a href="#">Deductible</a> ?	For <a href="#">In-Network Provider</a> <b>\$200</b> person / <b>\$400</b> family. For <a href="#">Out-of-Network Provider</a> <b>\$1,000</b> person / <b>\$2,000</b> family.	Generally, you must pay all of the costs from <a href="#">Provider</a> s up to the <a href="#">Deductible</a> amount before this <a href="#">Plan</a> begins to pay. If you have other family members on the <a href="#">Plan</a> , each family member must meet their own individual <a href="#">Deductible</a> until the total amount of <a href="#">Deductible</a> expenses paid by all family members meets the overall family <a href="#">Deductible</a> .
Are there services covered before you meet your <a href="#">Deductible</a> ?	Yes. Pharmacy, services that require <a href="#">Copays</a> , immunizations or <a href="#">In-Network</a> hospice care and <a href="#">Preventive Care</a> are covered before you meet your <a href="#">Deductible</a> .	This <a href="#">Plan</a> covers some items and services even if you haven't yet met the <a href="#">Deductible</a> amount. But a <a href="#">Copayment</a> or <a href="#">Cost Sharing</a> may apply.
